**REGISTRATION AGREEMENT**

I/We hereby agree to and understand the terms and conditions of enrollment for my child.

1. **REGISTRATION FEES:** All fees must be paid before my child receives his/her uniform/equipment.
2. **UNIFORMS & EQUIPMENT:** I/We understand that all uniforms and equipment to my child is the property of the Sandy Springs Saints and must be returned at the end of the season. If uniform/equipment is not returned as agreed, parent/guardian will be liable for the entire cost of uniform/equipment (approx. \$230.00).
3. **REFUNDS:** No registration fee refunds will be issued after August 15th.
4. **NSF ITEMS:** A \$35.00 NSF fee will be assessed to all returned checks. In the event your check is returned for NSF, your child will be withdrawn from the program and unable to participate until all monies and NSF fees are paid.
5. **INSURANCE:** The Sandy Springs Saints supplies an excess accidental medical and dental policy. The coverage is payable in excess of all other valid and collectible group insurance. The plan has a \$250 deductible.
6. **COMMITMENT:** I/We will be a supportive parent/guardian for my child and my child's team by committing to 2 hours of volunteer service during the season.
7. **CODE OF RESPONSIBILITY:** It is the parent/guardian's responsibility to make sure that your child is at all practices and games on time and picked up IMMEDIATELY following the completion of practices and games. Neither the City of Sandy Springs, nor the Sandy Springs Saints assumes any responsibility for a child left at the park at the completion of any event, be it practice or game.
8. **VIDEO/PHOTO RELEASE:** As a Parent/Guardian of a child in the program, I hereby grant permission to Sandy Springs Youth Sports (SSYS) to use my child's photograph on its World Wide Web site or in other official SSYS printed publications without further consideration. I further acknowledge SSYS's right to crop or treat the photograph at its discretion. I also acknowledge that SSYS may choose not to use my child's photo at this time, but may do so at its own discretion at a later date. I also understand that once an image is posted on SSYS's website, any computer user will have access to the images. Therefore, I agree to indemnify and hold harmless SSYS from any claims.
